Represented a defendant charged with arson with intent. We obtained an acquittal.

R v BH, St Albans Magistrates Court

Represent a defendant charged with two counts of assault and threats to cause criminal damage. We obtained an acquittal.

R v H&P, St Albans Magistrates Court

Represented two co-defendants charged with actual bodily harm. We obtained an acquittal.

### **Theft, Burglary & Robbery**

R v A, Maidstone Crown Court

Represented a defendant charged with conspiracy to commit robbery, possession of a firearm with intent and s.18 grievous bodily harm. We obtained an acquittal.

R v MH, St Albans Youth Court

Represented a defendant charged with robbery. We obtained an acquittal.
